Five Kenyans filed the claims and sought reparations for alleged British war crimes committed during the Mau Mau Emergency. The claimants' case was based upon the research and findings of *Imperial Reckoning*. Document discovery during the case produced the largest, recent release of new files related to the end of the British Empire. Together with a team of five Harvard students, I excavated these documents for the High Court. The case settled in June 2013, and included the British Government's apology issued in the House of Commons, and reparations of £20 million to 5,228 claimants who were included in the final settlement.
